

Terms of Use Agreement

Welcome to BCTD.org web site. By using this site, you are agreeing to comply with and be bound by the following terms of use. Please review the following terms carefully. If you do not agree to these terms, you should discontinue using this site. The term "BCTD.org" or "us" or "we" or "our" refers to Building and Construction Trades Department and Oswego Creative, the owner and operators of the BCTD.org web site. The term "you" refers to the user or viewer of our Web Site.

1. Acceptance of Agreement.

You agree to the terms and conditions outlined in this Terms of Use Agreement ("Agreement") with respect to our site (the "Site").
